-The ministry's high school graduation rate is 84.4% with 76 of 90 youth earning a diploma or GED between 2009 and 2016. The graduation rate for the general population is 81.4% according to America's Health Rankings and the rate for foster care youth is 54% according to the Casey National Alumni Study.
-The campus-wide GPA recently reached an all-time high of 3.10.
-BMH staff has been trained to incorporate the CARE Program Model which focuses on providing evidence based and trauma informed care that is consistently in the best interests of our children.
-The average length of employment for staff is nearly five years with 16 staff members serving for longer than five years and 13 for more than 10 years.

-Financial and in-kind gifts were given to the Home by 100% of staff and the Board of Directors.
-In 2014, the Home received accreditation from the Council on Accreditation-the gold standard in the industry. The ministry has also earned a four-star Charity Navigator rating.
-In FY 2015-2016, BMH hosted 2,608 volunteers from 19 states doing 21,300+ hours of work valued at more than \$490,000.
-As the Home has expanded its continuum of care the number of children served has grown from 51 youth in residential care in FY 2008-2009 to 118 children in foster care, residential care, and independent living in FY 2015-2016.
